

2026 Beaufort Hardware & Paint Benny & Dewey's 3 Bean Cafe Grand Opening Contest

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. PROMOTION DATES

a. The **Benny & Dewey's 3 Bean Cafe Grand Opening Contest** ("Promotion") will begin on July 1, 2026 at 12:00 am ET and end on July 31, 2026 at 11:59 pm ET. The winners will be notified by August 10, 2026.

2. ELIGIBILITY RESTRICTIONS

a. The Promotion is open to all legal residents of the United States and the District of Columbia (except NY and FL) who are 18 years of age or older at the time of entry and who live in North Carolina. Employees of **Beaufort Hardware & Paint** (the "Sponsor"), its parent, subsidiary, and affiliated entities, its advertising agencies, participating sponsors/promotional partners and the members of their immediate families (spouse, parents, siblings or children) or households (whether related or not) are ineligible to participate or win. This Promotion is subject to all applicable federal, state, and local laws and regulations. Void outside the United States, in NY and FL, as applicable, and where prohibited.

b. Entrants are required to provide truthful information and the Sponsor will reject and delete any entry that it discovers to be false or fraudulent. The Sponsor will disqualify any entry from individuals who do not meet the eligibility requirements and will also delete any entry as required by law.

3. ENTRY

b. For Internet entry, only one entry per person and one entry per email address are permitted.

4. PRIZES

a. 8 grand prizes, includes: 3 Bean Hat (\$20 value), 3 Bean Tumbler (\$30 value) and Mini Bucket with winner's choice of ice cream (Double Scoop with 1 topping) (\$7.50 value). Ice cream is from 3 Bean Cafe and to be picked up when the winner picks up the prize.

b. There is no substitution, transfer, or cash equivalent for prizes, except that the Sponsor may, at its sole discretion, substitute prizes of comparable value or cash. The prizes are expressly limited to the item(s) listed above and do not include taxes, gratuities or any other expenses. Other restrictions may apply.

5. WINNER SELECTION AND NOTIFICATION

a. Decisions of Sponsor management with respect to the Promotion are final.

b. The winner will be chosen by drawing a name at random from the entries received on the website form and on social media. There will be 8 winners for this contest.

c. ODDS OF WINNING DEPEND UPON THE NUMBER OF ENTRIES RECEIVED, AS APPLICABLE.

d. The winner will be notified by email or by social media. Winner(s) (or their parents or legal guardians if under the age of majority) must execute and return any required affidavit of eligibility and/or liability/publicity release within ten (10) days of notification attempt or winner will be disqualified and the prize will be forfeited and an alternate winner(s) may be chosen by random drawing. If a potential winner(s) cannot be contacted, fails to complete, sign and return the required affidavit of eligibility and liability/publicity release within the required time period, or if a prize or prize notification is returned as undeliverable, the potential winner(s) will be disqualified and will forfeit the prize.

b. By entering, participants grant the Sponsor permission to use submitted pet photos on its website, social media platforms, and in printed promotional materials such as a calendar.

c. Prior to awarding any prize or prize certificate and depending on the nature of the prize and eligibility requirements of the Promotion, the Sponsor in its sole discretion will require verification of Promotion winner's or winners' identification by a showing of valid government-issued photo identification. d. The Sponsor, in its sole discretion, reserves the right to disqualify any person (and all of their entries) from this Promotion if he or she tampers with the entry process, the operation of the Promotion, or the operation of the Sponsor's web channel or is otherwise in violation of the rules. The Sponsor further reserves the right, at its sole discretion, to modify, cancel, terminate or suspend the Promotion, or any part of it, if it is not capable of completion as planned or if any fraud, technical failures or any factor beyond the Sponsor's control, including infection by computer virus, bugs, tampering, unauthorized intervention or technical failures of any sort, corrupt or affect the administration, security, fairness, integrity or proper conduct of the Promotion as determined by the Sponsor in its sole discretion. Any attempt by an entrant or any person to deliberately damage any Sponsor web channel or to undermine the legitimate operation of this Promotion may be a violation of criminal and civil laws. Should such an attempt be made, the Sponsor reserves the right to seek full prosecution and/or damages from any such individual to the fullest extent permitted by law. The Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of this provision. If due to circumstances beyond the control of the Sponsor, any competition or prize-related event or travel is delayed, rescheduled, postponed or cancelled, the Sponsor reserves the right, but not the obligation, to modify, terminate, suspend or cancel the Promotion and shall not be required to award a substitute prize.

e. The Released Parties are not responsible for (i) typographical or other errors in the printing, the offering or the administration of the Promotion, or in the announcement

of a prize; (ii) entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties, malfunctions, disconnections, other technological failures, telephone service outages, delays, dropped calls, or busy signals, or any other difficulties that may prevent an individual from sending or receiving a text message; or (iii) lost, stolen, mangled, misdirected, postage due, illegible, incomplete, incorrect, or late entries.
